- Returned Direct Debit - If a direct debit is returned, you will be liable for bank charges. If a direct debit is returned twice, Glen Fuels will withdraw this facility from your Glen Fuels account. A returned Direct Debit will be notified to you by email and you will be required to phone our office with a credit/debit card payment. Glen Fuels reserves the right to apply a €20 admin fee for failed direct debits, which will be collected at the next payment date.
- Cancellation - You have the right to cancel your SEPA Direct Debit at any time by writing to Glen Fuel Services Ltd. and informing your bank, building society, or credit union in good time.
